CHARLOTTE PASS KOSCIUSZKO NATIONAL PARK

Enjoy a day out in the **Kosciuszko National Park** with a visit to **Charlotte Pass Village**, Australia's highest ski resort. Although snowbound for most of the ski season, during summer we can drive to the village. At 1765 metres above sea level, it is Australia's oldest and highest resort and is named after Charlotte Adams who was the first woman to climb **Mt Kosciuszko**. Charlotte Pass is in the middle of Kosciuszko National Park and some of the area's most idyllic alpine scenery. Enjoy lunch at **The Kosciuszko Chalet** which was established in 1930 and is the birthplace of modern skiing in Australia. On our way to Charlotte Pass we enjoy a tour of the **Gaden Trout Farm**. On our way home, we visit the **Snowy Regions Visitor Centre** at **Jindabyne**.
