Day 1: (LD) CANBERRA TO MAITLAND: Monday 01 August 2022

Welcome aboard our **Winter Getaway** to the mid north coast of NSW. Once we've loaded the coach, we're ready to go. After a stop for a **club lunch** we continue to **Maitland**, a charming region with a rich history, emerging food scene and a thriving arts community.

Day 2: (BLD) MAITLAND TO NAMBUCCA HEADS: Tuesday 02 August 2022

Our morning's drive takes us via Nabiac to **Laurieton** where we travel up North Brother Mountain for magnificent views of the **Camden Haven** area. The spectacular scenery of the coastal route then takes us into **Port Macquarie**. **Lunch** is at the splendid **Sea Acres Rainforest Park**, comprising of 72 hectares of rare coastal rainforest. Our final destination is **Nambucca Heads**, a wonderful spot from which to explore. The town sits at the mouth of the river with its sparkling estuary being home to playful dolphins. On arrival we are joined on the coach by a **local expert** who will share some interesting stories of life in Nambucca Heads.

Day 3: (BLD) BELLINGEN: Wednesday 03 August 2022

Taking our time with breakfast, we then travel up the Dorrigo Plateau to the National Park. We see some magnificent rainforest country and stunning views. The information centre and a number of easy walks will introduce us to the beauty and serenity of the rainforest. The **Skywalk** will provide us with some spectacular views. Retracing our steps to the historic township of **Bellingen**, we enjoy **lunch** at the Old Butter Factory Café. Bellingen is nestled on the banks of the beautiful Bellinger River and once the centre of a thriving timber industry. The town's traditional-style main street, the highlight of which is the restored Hammond and Wheatley Emporium, is as grand as its name suggests. After the chance to look around, we head to Urunga where we stop to visit the **Honey Place** before travelling back to our hotel.

Day 4: (BLD) TAYLORS ARM: Thursday 04 August 2022

Our touring today takes us to **Taylors Arm**, an area of undulating landscape and state forests. The early days saw cedar felling and dairying but today we are stopping in at **Perry's Lemon Myrtle** for a talk on the farm and their products. **Morning tea** will also be served. Lemon myrtle is native to Australia and its popularity is ever-increasing, perhaps due to its rarity. The area is also famed as the true location of the **Pub With No Beer**. For just over 100 years, the Pub With No Beer has been dispensing Australia's most valuable liquid asset, beer. Legend has it, however, that it once ran out! Local timber cutter and

songwriter, Gordon Parsons, immortalised this story into a very famous song and then recorded by Slim Dusty. We'll salute the King of Country today and enjoy our **lunch** here including time to view an array of artefacts and memorabilia, each with its own interesting history, adorning the pub walls. Later we visit the small country town of **Bowraville**, known as the Verandah Post Town and not a lot has changed over the years. Exploring the town, drop into the **Bowraville museum**, an incredible museum that must truly be seen to be understood. We take some time to explore the town and the many craft shops then return to our motel.


Day 5: (BLD) NAMBUCCA HDS TO THE ENTRANCE: Friday 05 August 2022

Not far from here is **South West Rocks**, a seaside town with intriguing colonial heritage. Visiting **Trial Bay Gaol** we undertake a **guided tour** to soak up the history of this primitive ruin. It stands as a testament to those who called this home and we will have a museum and memorial to view. Closed for good after World War I, it has many stories to tell. We now head to the Central Coast, stopping to enjoy **picnic lunches** along the way.
