Day 2: (BLD) RIVERBOAT POSTMAN CRUISE: Thursday 30 May 2024

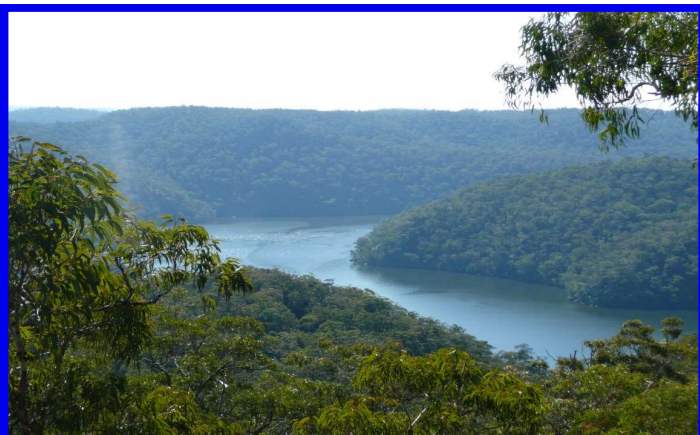

Back on dry land, we head to ***Mt Penang Gardens***. Considered as an enduring and radical contribution to public garden design in Australia, we enjoy a stroll through the beautiful grounds; from themed garden rooms to its clever use of water. We'll then return to our hotel and freshen up before dinner.
