#### Day 1: (LD) CANBERRA TO MAITLAND: Tuesday 3 December 2024

Welcome to our 3 day tour to witness the **spectacular Christmas Lights** at the glorious Hunter Valley Gardens. Getting underway, we travel north stopping for **lunch** before reaching **Newcastle**. Originally named Coal River, the town was founded in 1804 as a place for the most intractable of Sydney's convicts – and was known as the 'hell of NSW'. A **local guide** will join us on the coach to share its history and show us this city of industry with its terraced houses, majestic cathedral and ancient fort. We then continue through to our destination of **Maitland**. Upon arrival we check into our motel for the next two nights before dinner.

#### Day 2: (BLD) THEATRE LUNCH & CHRISTMAS LIGHTS: Wed 4 December 2024

Easing into the day, we venture to **Kurri Kurri** to explore the vibrant outdoor public artworks on display. Embarking on a pictorial journey that narrates the area's rich history, heritage and uniqueness the town's murals unfolds a story of events that shaped the town's character. From here we immerse ourselves in the captivating world of **Aunty Molly** and her acclaimed **cabaret-themed luncheon show** promising entertainment, laughter and a delightful lunch all complemented by a fabulous singalong with **Toni Stevens (aka Toni McLean / Aunty Molly)**. Returning to Maitland, with some time to freshen up and enjoy a light dinner before setting off for the enchanting **Hunter Valley Gardens**. As the sun begins to set, the Gardens burst into brilliance with the **Christmas Lights Spectacular**. Step into a world where over 100,000 Christmas lights illuminate the surroundings, guiding us through the extraordinary displays, including a winter wonderland featuring a snow cave and snow-dusted trees that breathe life into the festive spirit of Christmas.





#### Day 3: (BL) MAITLAND TO CANBERRA: Thursday 5 December 2024

We farewell our hosts and travel to the **Mortels Sheepskin Factory** where we explore their purpose-built shed and witness a fully operational manufacturing plant in action. Delve into the process of crafting UGG boots, seeing how they transform from raw materials to the final creation. Our journey then leads us to **Berowra** for an early **lunch** before we proceed on to Canberra. As we arrive home later this afternoon, we express our gratitude to our coach captain and take a moment to reflect on the delightful experiences of the past 3 days, where we can now start to be excited for Christmas!

#### **CANCELLATION BY YOU:**

- 3. a fee which is the greater of the deposit and 20% of the booking value to compensate us for work performed up until the time of cancellation;
- 4. a fee not greater than 5% of the booking value to compensate us for processing the cancellation and any associated refund.

Cancellation fees and charges will not exceed payments received by us at the time of cancellation. If after the application of these fees and charges there is a surplus of payments you have made to us, we will refund this to you within a reasonable time. You agree that these cancellation fees and charges are reasonable and required to protect our legitimate business interests. Any payments we have made to third parties will only be refunded to you once we have deducted the above cancellation fees and charges and once we have actually recovered the amounts from the third parties. We will use reasonable endeavours to recover third party payments, but we make no guarantee that we will be able to make recoveries.
